# STATUTORY CHARGES FOR THE DCA'S AIRWORTHINESS FUNCTIONS AND PRICES OF AIRWORTHINESS PUBLICATIONS

### 1. Introduction

I

The purpose of this Notice is to highlight the scheme of charges for airworthiness and associated functions made in accordance with the Malaysian Civil Aviation Regulations 1996, Twelfth Schedule, Part B. For full details, reference should be made to the Schedule itself, which constitutes the authoritative text. All charges etc. are quoted in Malaysian Ringgit (RM).

This Notice also includes airworthiness publications, which are available for purchase from the DCA.

The applicant is required to provide a written undertaking to the DCA that he will accept responsibility for reimbursement of this expenditure.
- **10.** All fees for statutory functions are payable in Malaysian Ringgit only and cheques etc. should be made payable to the Director General of Civil Aviation. Payment of invoices raised for expenditure incurred as a result of visits to foreign countries (refer to paragraph 9 of this Notice) should be made in accordance with the instructions of the invoice.
