Subject: Airworthiness Directives

By the virtue of section 35 of the Air Navigation Act B.E. 2497 which amendment by the Air Navigation Act (issue 9) and the statement in Article 1 of the Announcement of the Ministry of Transport, subject: the Appointment of the Competent Official, Given on 18 May B.E. 2532. The Director General of the Department of Civil Aviation on behalf of a competent official shall specify the condition for issue Airworthiness Directives as follows:

Article 1 In this announcement "Airworthiness Directives " means the orders of a competent official issued for inspection or rectification of aircraft, engines, propellers and appliance installed in aircraft including for correcting the operating procedures and limitations when a competent official found that the aircraft, engines, propellers and appliances installed in aircraft are not in conditions for safe operations and that condition is likely to exist or develop in any other aircraft, engine, propeller or aircraft component of the same design.

- No. 2 The Director of Aircraft Engineering Division, Flight Standard Bureau, Department of Civil Aviation on behalf of a competent official under the ADCA subject: The Appointment of a competent official Announce on 28 November B.E. 2548 shall issue Airworthiness Directives by using the Airworthiness Directive form attached to this announcement.
- No. 3 Thai Aircraft shall fly when they has been complied with the tasks in period of time in accordance with those prescribed in the Airworthiness Directives of the effective aircraft, engine, propeller or aircraft component.
- No. 4 Airworthiness Directives issued by State of design for aircraft, engines, propellers and appliances or documents issued by the designer or manufacture such as Mandatory SB, Mandatory Modification,

Mandatory Inspection shall be deem to be the Airworthiness Directive under this announcement.

No. 5 This announcement shall be effective from day after the date of announcement.
