# **AERIAL WORK SUPERVISION**

## **1 INTRODUCTION**

### **1.1 This AIC applies to commercial aircraft operations used for specialised services**

References :

- a. MCAR Regulations 17, 24, 65 & 181
- b. ICAO Doc 9408-AN/922 Manual of Aerial Work

## **2 SPECIALISED SERVICES**

2.1 The specialised services that fall under this category are as follows :

- A. Aerobatic Flights
- B. Agricultural Aircraft Operation
- C. Banner Towing
- D. Economic Poison
- E. Rotocraft Load Combinations

## **3 AIR OPERATOR'S CERTIFICATE**

Aerial work aircraft operations within Malaysia is required to be issued with commercial Air Operator's Certificate (AOC) and Aerial Application Certificate (AAC) for those operations

### **3.1 Certificate Required**

Except in a public emergency, for relief and welfare activities, approved by an agency of the national or the local government, no person may conduct aerial work aircraft operations without, or in violation of, an Aircraft Operator Certificate (AOC) and Aerial Application Certificate (AAC) issued by the Authority.

### **3.2 Application for Certificate**

An application for an AOC and AAC shall apply on a form subscribed by the Authority

### **3.3 Amend of Certificate**

An AOC and AAC may be amended on the authority's own initiative, under applicable laws and regulations; or upon application by the holder of that certificate

## 4 CERTIFICATIONS REQUIREMENTS

4.1 The authority will issue a commercial aerial work AOC and AAC to an applicant who meets the requirements for the certificate. A commercial operator-pilot applicant shall hold, or have available, the services of at least one pilot who holds a current Malaysian Commercial or Airline Transport Pilot Licence issued by the Authority and who is properly rated for the aircraft to be used.

## 5 DURATION OF CERTIFICATE

5.1 An aerial work Aircraft Operation Certificate is effective for one year and renewable until it is surrendered, suspended or revoked

## 6 OPERATING RULES

### 6.1 Carrying of Certificate

No person may operate an aircraft unless a copy of the AOC and AAC is carried on that aircraft. The registration and airworthiness certificates issued for the aircraft need not be carried in the aircraft provided that those certificates not carried in the aircraft shall be kept available for inspection at the base from which the operation is conducted.

### 6.2 Availability of Certificate

Each holder of an AOC and AAC shall keep the certificate at its home base and shall present it for inspection on the request of the Authority or any government law enforcement officer.

### 6.3 Change of Address

Each holder of an AOC and ACC shall notified the authority in writing in advance of any change of address of its home base of operations.

### 6.4 Termination of Operations

Whenever a certificate holder ceases operations it shall surrender that certificates to the designated office of the authority.

## 7 IMPLEMENTATION

All aerial work operators shall comply with this instruction immediately.
