

Ministerial Regulation Prescribing Rules and Procedures for Applications of

a Type Certificate of an Aircraft or Major Aircraft Appliance

B.E. 2553

By virtue of Section 6 (5) and the first paragraph of Section 38 of the Air Navigation Act B.E. 2497 as amended by the Air Navigation Act (No. 11) B.E. 2551, which is a law containing provisions which restrict the rights and liberties of the people, and given that Section 29, in conjunction with Sections 32, 34, 41, and 43 of the Constitution of Thailand, grants the authority to prescribe restrictions on the rights and liberties by virtue of the law, the Minister of Transport hereby issues the following regulation:

Any person who wishes to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance shall submit an application to the Director General using the form as prescribed and notified by the Director General, together with the following documents and evidence:

- (1) In case of the applicant for a Type Certificate of an Aircraft or Major Aircraft Appliance is a Natural Person:
- (a) A copy of an ID or another document which issued by the Government services using as a substitute of an ID, in case of the applicant for a Type Certificate of an Aircraft or Major Aircraft Appliance hold Thai nationality. A copy of a foreigner ID or passport, in case of the applicant for a Type Certificate of an Aircraft or Major Aircraft Appliance is a foreigner.
- (b) An Aircraft Type or a Major Aircraft Appliance Type wishes to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance shall include at least, the sketch and schematic for assessing the feasibility of the proposed type design.

- (c) The plan and period of time for constructing the prototype aircraft or prototype of the Major Aircraft Appliance which to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance.
- (d) The processes and procedures to construct the prototype Aircraft or prototype of the Major Aircraft Appliance which to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance.
- (e) The purpose of operations of an Aircraft or a Major Aircraft Appliance which to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance.
- (f) The financial status of the applicant for a Type Certificate of an Aircraft or Major Aircraft Appliance such as the evidences to show the source of capital and using or the investment in other business, the yearly financial report or the document to certify the financial status.
- (h) The estimation of the expense to construct the prototype Aircraft or prototype of the Major Aircraft Appliance which to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance.
- (g) The staffs for using to construct the prototype Aircraft or prototype of the Major Aircraft Appliance which to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance such as the number, knowledge/competency and experience of those staffs.
- (i) The right of ownership or the possessory right or the right to use the areas for using to construct the prototype Aircraft or prototype of the Major Aircraft Appliance which to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance
- (j) The tools for using to construct the prototype Aircraft or prototype of the Major Aircraft Appliance which to obtain a Type Certificate of an Aircraft or Major Aircraft Appliance such as the character, category and type of tools.
 - (k) Other documents and evidences as prescribed by the Director General.
- (2) In case of the applicant for a Type Certificate of an Aircraft or Major Aircraft Appliance is a Juristic Person:
- (a) The copies of an approved letter or evidence to show being a Juristic Person which indentifying the currently of the name, purpose, office location, and the person who having been authorized to sign on behalf of the juristic person. Those documents shall be certified by the person who has the power in accordance with the laws and shall be valid only 6 months from the date of certification.

- (b) The documents under (1) (a) of the person who has the power to sign on behalf of the juristic person.
 - (c) The documents under (1), (b), (c), (d), (e), (f), (g), (h), (i) and (j).
 - (d) Other documents and evidences as prescribed by the Director General.
