Malaysian and Comparative Law Centre (MyCoL) is a research centre located at the Faculty of Law. Universiti Kebangsaan Malaysia (UKM). MyCoL, which officially operates from December 2019, consists of 19 members comprising 2 Professors, 7 Associate Professors, 9 Senior Lecturers, and 1 Lecturer from the Faculty of Law, UKM with various areas of expertise.

The Faculty's vision and objectives form the basis of MyCoL's operation, with a focus on local and comparative legal studies. For this purpose, MyCoL established an active network with various agencies, institutions, and organizations at home and abroad. This network involves research collaborations, training, and consultations.

## **CENTRE FOR INTERNATIONAL** LAW & SIYAR (CILAS)

Centre for International Law and Siyar (CILAS) is the first Centre of Excellence at the Faculty of Law, Universit Kebangsaan Malaysia (UKM) and was establised in 2014. CILAS consists of 21 members comprising 3 Professors, 7 Associate Professors, 10 Senior Lecturers and 1 Lecturer from the Faculty of Law, UKM with various areas of expertise.

The Faculty's vision and objectives form the basis of CILAS's operation, with a focus on legal and international policy and Siyar in Malaysia, ASEAN and the Muslim countries. For this purpose, CILAS established an active network with various agencies, institutions and organizations at home and abroad. This network involves research collaborations, trainings and consultations.




