I am pleased to inform you that the Asia-Pacific Telecommunity (APT) is inviting APT Members to submit a project proposal(s) on “Promoting the Use of ICT for Achievement of Sustainable Development Goals”, to be funded by the Extra-Budgetary Contribution from the People's Republic of China (EBC-C).

The objective of the EBC-C is to promote the use of ICT applications in APT Members in addressing socio-economic issues such as poverty, digital divide, health, education, clean energy, infrastructure development, sustainable cities and communities, etc.

The proposed project of APT Members is required to be implemented by beneficiary countries (APT Members) in cooperation with Chinese experts. The project may be composed of, but not limited to, field study/survey by experts, study visit to China, joint research and pilot projects. The maximum financial support from EBC-C for each project is USD 100,000. The implementation of the proposed project is to be completed within 24 months from the date of the selection notification by APT Secretariat.
